Terms of Business: To have a Sensor repaired/re-calibrated please adhere to the following for smooth and quick transaction:

- 1) We must have the **RMA (Return Material Authorisation) form duly filled** to give us advance notice of the delivery of sensors, the quantity and weight. The form can be freely downloaded from the MIL web site.
- 2) We need to have **the purchase order number reference.**
- 3) **The Sensor is** clearly identified with its **serial number** and specification sheet
- 4) **Your approval for the repairing charges and the cost of the components, if any, that is extra will be required** for which a separate **quotation will be sent** prior to undertaking the work. Please note that the repairing and recalibration will not be undertaken unless we have your approval. Also, please note, the sensor needs re-calibration after repairs.
- 5) **Inspection charges of Rs. 500/- per sensor will be payable** if the sensor is required to be collected without repairing/re-calibration.
- 6) **Service Tax @ 10.3% and Sales Tax @ 10%** and other taxes and levies will be charged at the prevailing rate at the time of despatch.
- 7) **Octroi is applicable in Mumbai. Octroi paid by us, if any, plus the expenses incurred by us thereby will be reimbursed by you immediately.**
